OHIO CHILDREN'S TRUST FUND REQUEST FOR PROPOSALS SPECIFICATIONS

The Lorain County Children & Families Council (Council) is soliciting proposals that assist Council in creating a community for infants, toddlers, and children to thrive by reducing the prevalence of child maltreatment in Lorain County.

Per Ohio Revised Code 3109.13, Ohio Children's Trust Fund monies are dedicated exclusively to primary and secondary child abuse and neglect prevention programs and services. Primary and secondary prevention includes a variety of services, which support and strengthen families, promote protective factors and reduce or eliminate risk factors that can lead to child maltreatment. Lorain County will be awarding up to \$91,365 across a minimum of two (2) selected programs.

Priority for selection will be given to agencies who demonstrate the following:

- Provide an evidenced-based program identified to specifically prevent child abuse and implement to a high degree of fidelity to program design. The proposal package contains a list of eligible programs.
- 2) Ability to provide strong performance measures that result in increasing protective factors and reducing risk factors in targeted families.
- 3) Ability to maximize resources, ensure cross system/program referrals, and work collaboratively with community partners.
- 4) Ability to accurately capture program participant data using a State-mandated database.

This funding is for State Fiscal Year 2016 (July 1, 2015 - June 30, 2016).
