WHEREAS, bids were received and opened on Wednesday, November 21, 2018 for the Clinton Ave Ditch Storm Water Management Facility. The project plans and specifications included a base bid with a scope of work. Bids were received from seven contractors as follows:

As specified in Section 00-03-00 (General Provisions, Award of Contract), the apparent low bidder for the project was determined from the Base Bid prices. The lowest Base Bid amount was received from D & M Earth Moving, LTD. in the amount of \$272,342.92.

BE IT FURTHER RESOLVED, that we do and hereby issue a Notice to Proceed effective on or before Dec. 31, 2018 and to complete said contract on or before June 14, 2019.


FURTHER BE IT RESOLVED, the County Administrator is hereby granted the authority to notify the County Auditor to release retainage at the completion of the contract.
