WHEREAS, Ken Carney, Lorain County Engineer duly advertised for bids and the following bids were opened on April 22, 2021;

Schirmer Construction, Inc.	\$226,772.00
KUM Trucking & Excavating	\$227,985.56
Denes Concrete, Inc.	\$243,084.00
S.E.T., Inc.	\$253,722.07
Senghas Construction	\$259,080.00

And;

WHEREAS, this project includes placing a cut off wall along the bottom of the arch at both abutments to provide protection against scour; and

WHEREAS, Engineer is recommending Schirmer Construction, Inc. They agree to commence work on or before July 19, 2021 and complete all work by October 30, 2021. They have proposed no substitutions and subcontractors for this project are Cuyahoga Bridge & Road, Seville, Ohio.

NOW, THEREFORE, BE IT RESOLVED by the Board of Lorain County Commissioners, that based upon the recommendation of Lorain County Engineer we hereby approve and enter into a contract with Schirmer Construction, Inc., North Olmsted, Ohio, in the amount of \$226,772.00 for the Stoney Ridge Rd. Bridge #0424 Rehabilitation project in the City of Avon.


FUTHER BE IT RESOLVED, we will issue a Notice to Proceed upon full execution of the contract authorizing work to begin on or around July 19, 2021 and the work will be completed on or before October 31, 2021.

BE IT FURTHER RESOLVED, we hereby authorize The Lorain County Administrator to notify The County Auditor to release retainage at the completion of the project.

NOW, BE IT RESOLVED, we hereby approve with Schirmer Construction, Inc., North Olmsted, Ohio, in the amount of \$226,772.00. The Ohio Public Works Commission will contribute 89%, or \$201,827 of the project costs as a grant. The remaining \$24,945 will be provided by The Lorain County Engineer, account 2580-0000-300-302-04-6100-6105.
