WHEREAS, Ken Carney, Lorain County Engineer, by letter dated June 29, 2015 submitted the following:

“We have reviewed the bids that were received for the Jones Road Bridge #1016 Replacement project in Penfield Township. The respondents to this bid were:

BECDIR	\$1,534,855.90
Mosser, Construction, Inc.	\$1,569,276.05
R & I Construction, Inc.	\$1,593,216.43
Armstrong Steel Erectors, Inc.	\$1,706,106.76

BECDIR proposes to complete all work by July 1, 2015. BECDIR does not propose any substitutions but will be using DOT Diamond Core Drilling, Ambry Asphalt or Barbicas, Blackswamp Steel, Inc., M.P. Dory Co., The C.J. Zak Co., Inc., Neumeyer Environmental Services, Inc., Trafftech, Inc., Athos Contracting and Toledo Caisson Corporation or various portions of this project.

We recommend that the contract for the Jones Road Bridge #1016 Replacement project in Penfield Township be awarded to BECDIR, Berlin Center, Ohio in the amount of \$1,534,855.90.

The estimated cost of this work is \$1,600,000.00. Funding is being provided by 95% Federal Funds. The remaining 5% will be provided by the Lorain County Engineer, MVGT funds, Engineering Projects Bridge Account #2580-0000-300-302-04-6100- 6105.

Thank you for your cooperation with this project.”;


NOW, THEREFORE, BE IT RESOLVED by the Board of Lorain County Commissioners, that based upon bids received and review and recommendation by the Lorain County Engineer in letter dated June 29, 2015 we do hereby award contract to BECDIR in the amount of \$1,534,855.90 for the Jones Road Bridge #1016 Replacement project in Penfield Township.

BE IT FURTHER RESOLVED that this project is being funded 95% Federal Funds with the remaining 5% provided by the Lorain County Engineer MVGT funds, Engineering Projects Bridge Account No.2580-0000-300-302-04-6100-6105.
