WHEREAS, Ken Carney, Lorain County Engineer, by letter dated May 24, 2016 submitted the following:

“We have reviewed the bids that were received for the Oberlin-Elyria Road/East 31st Street Bridge Improvements as follows:

Suburban Maintenance	\$312,676.00
Denes Concrete	\$324,292.00
Mid-Ohio Structures	\$402,607.82

Suburban Maintenance proposes to complete all work by November 4, 2016. Suburban Maintenance did not propose any substitutions but will be using Susan R. Bauer, Inc., for the fabrication of expansion joint assemblies and Cleveland Barricading Systems for the MOT Plan implemented by the County for this project.

We recommend that the contract for the Oberlin-Elyria Road/East 31st Street Bridge Improvement project be awarded to Suburban Maintenance in the amount of \$312,676.00.

The Engineer’s estimated cost of this work was \$318,809.00. \$134,600.00 is being provided by the Ohio Public Works Commission. The remaining balance will be provided by the Lorain County Engineer’s Office, MVGT funds, Engineering Projects Bridge Account #2580-0000-300-302-04-6100-6105.

Thank you for your cooperation with this project.”;

NOW, THEREFORE, BE IT RESOLVED by the Board of Lorain County Commissioners, that based upon bids received, reviewed and recommendation by the Lorain County Engineer in letter dated May 24, 2016 we do hereby award contract to Suburban Maintenance & Construction of North Royalton, Ohio in the amount of \$312,676.00 for the Oberlin-Elyria Road /East 31st Street Bridge Improvements.

This was the lowest and most responsive bid received and complied with all specifications.


