WHEREAS, bids were received and opened on Friday, November 2, 2018 for the Fortune Ditch Stream Restoration Project. The project plans and specifications included a base bid scope of work and two bid alternate items. Bids were received from nine contractors as follows:

NOW THEREFORE BE IT RESOLVED by the Lorain County Board of Commissioners that we do and hereby award a contract to Mark Haynes Construction, Inc. 3130 State Route 18 E. Norwalk, Ohio 44857 in the amount of \$270,282.34 for the Fortune Ditch Steam Restoration Project. This contract price includes the Base Bid amount as well as the Bid Alternatives 1 and 2 amounts which will be utilized to further enhance the project. Funds are available from account #3412.3415.100.116 .07.6200.0000.

BE IT FURTHER RESOLVED, that we do and hereby issue a Notice to Proceed effective on or before November 15, 2018 and to complete said contract on or before July 31, 2019.


BE IT FURTHER RESOLVED, the County Administrator is hereby granted the authority to notify the County Auditor to release retainage at the completion of the contract.
