This correspondence is to notify you that Rumpke of Ohio, Inc. has been selected as the Successful Bidder by eleven of the Lorain County Consortium's participating communities. Pursuant to the terms of the invitation to bid, Rumpke is to execute and deliver to the participating community two counterparts of the Agreement within ten (10) days of the Notice of Award. Each Notice of Award is dated January 31, 2019. If two executed copies of the Agreement and the Notice of Award are not executed and returned to the participating community within ten (10) days the community, at its discretion, may determine Rumpke has abandoned the agreement.

In addition to executing the necessary documents, unless waived by a participating community, Rumpke must furnish and maintain for the terms of the Agreement, a performance bond executed by a duly authorized surety in the amount of 100 percent of the base bid amount for the performance of one year of the contract term. The performance bond must be issued within ten (10) days of receipt of the Notice of Award.
