WHEREAS, the Lorain County Engineer by letter dated January 19, 2021 submitted the following:

We have reviewed the bids that were received for the North Ridge Road Resurfacing & Watermain Replacement project in Sheffield and Elyria Townships. The respondents to this bid were:

Fabrizi Trucking & Paving	\$2,478,064.00
Underground Utilities	\$2,506,524.95
Buckeye Excavating	\$2,758,814.25
Perk Co.	\$2,824,887.15
Terrace Construction	\$2,992,350.32
Hillabrand & Sons	\$3,015,836.37

Fabrizi Trucking & Paving agrees to commence work on or before March 1, 2021 and complete all work by November 30, 2021. They have proposed no substitutions and Erie Blacktop Inc. and American Roadway Logistics as subcontractors for this project.

The project consists of planning and resurfacing North Ridge Road from the Lorain City limits (0.2 miles east of Broadway) to SR 57. Work also includes abandoning an existing 10" watermain and replacing it with a 12" watermain from Elyria Ave. to SR 57.

NOACA will be providing funds for 80% of the project costs attributed to the roadway improvements. The remaining 20% of the road improvements will be paid for with funds from The Ohio Public Works Commission. Funding for the water line improvements will be through the Q Construction, Lorain County Sanitary Engineer North Ridge Road Project Fund account number 5000-5072-100-000-10-6100-6105 in the amount of \$1,300,000.00

We recommend that this bid be awarded to Fabrizi Trucking & Paving, Middleburg Hts., Ohio in the amount of \$2,478,064.00.


