WHEREAS, Resolution No. 16-517, adopted August 17, 2016 advertised notice to bidders on the Amherst parking facilities improvements on August 19 & 26, 2016; and

WHEREAS, bids were received on September 2, 2016 and awarded to Infinity Paving Company in the amount not to exceed \$142,470.00; and

WHEREAS, Bramhall Engineering and Survey Company was retained by the City of Amherst to perform construction inspection services and during the construction process unforeseen conditions necessitated the use of additional aggregate base materials to ensure the long term quality and viability of the parking facility. The additional materials were beyond the engineers estimates used during the bidding process which increased the construction costs in excess of the original award in amount of \$3,808.00.

NOW, THEREFORE BE IT RESOLVED, that the Lorain County Board of Commissioners hereby amends Res#16-517, adopted August 17, 2016 awarding contract to Infinity Paving Company to an amount not to exceed \$146,278 to reflect the additional costs associated with the construction of the Amherst Parking Facilities improvements CDBG Set-Aside Year 15 Grant Funds in the amount of \$113,400.00 will be provided for this project are available from account CDBG DT15 2060.DT15.100.07.6200.0000 (Contract Services). The City of Amherst will provide the remaining contract balance of \$32,878.

FURTHER BE IT RESOLVED, the County Administrator is hereby granted the authority to notify the County Auditor to release retainage at the completion of the contract.
