

LEGAL NOTICE

Separate sealed bids for Pheasant Run Sanitary Sewer Rehabilitation, Sewer District Improvement #123, Pheasant Run Subdivision, LaGrange Township, Lorain County, Ohio will be accepted by the office of the Lorain County Commissioners Purchasing Department in the Lorain County Administration Building at 226 Middle Ave, Elyria, OH 44035 until 1:00 PM, local time, on July 25, 2017 and then at said office publicly opened and read aloud.

Copies may be obtained at the office of the Lorain County Sanitary Engineer, 247 Hadaway Street, Elyria, Ohio 44035, between the hours of 8:00 A.M. and 4:00 P.M., Monday through Friday, upon payment of \$50.00 for each set. Checks shall be made payable to Lorain County Sanitary Engineer and all documents become the property of the prospective bidder, with no portion of the payment being refunded.

The Owner reserves the right to waive any irregularity which does not affect the competitive nature of the bidding process or to reject any or all bids.

Each bidder is required to furnish with its bid, a Bid Guaranty and Contract bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond Form shall be issued by a Surety company or corporation licensed in the State of Ohio to provide said surety.

Each bid must contain the full name of the party or parties submitting the bid and all persons interested therein. All contractors and subcontractors involved with the project will, to the extent practicable use Ohio Products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of the Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in Lorain County, Ohio as determined by the Ohio Department of Commerce or the U.S. Department of Labor.

This project includes cleaning, televising, and CIPP lining of approximately 4,324 LF of 6" diameter sanitary sewer, 4,508 LF of 8" diameter sanitary sewer, 2,366 LF of 10" diameter sanitary sewer, and 6,745 LF of 12" diameter sanitary sewer. This project also includes approximately 286 vertical feet of manhole rehabilitation, manhole inflow inserts, and 213 laterals reinstated and grouted. The estimated construction cost is \$1,168,000.
