Bids must be accompanied by a bid bond, certified check, cashier's check, Letter of Credit equal to ten percent (10%) of the amount bid or a Bid Guaranty and Contract Bond in the form bound in the Project Manual for the full amount of the bid or other acceptable bonding product as required by the Lorain County Port Authority. Should any bid be rejected such instrument will be forth with returned upon proper execution of a contract.
